If any portion of this request is denied, I respectfully request a detailed statement of the reasons for the withholding and an index or similar statement of the nature of any documents withheld. To expedite this request, I would be willing to discuss specific instances of deletion or other exemption claims in advance of a final decision by the agency. In the event of deletions, I request that a reason be stated for each partial denial of access.

<u>Payment</u>. In compliance with the applicable regulations, I promise to pay reasonable charges incurred for search and copying and any other legally required costs. Please send me your invoice along with the copies. If total
