1. SUMMARY: ON JANUARY 21, 2000, THE AMBASSADOR AND MOD SIGNED THE AMENDMENT TO THE END-USE MONITORING AGREEMENT (EUM). KEY CHANGE TO THE EUM IS THE DISSOLUTION OF THE PREVIOUSLY DESIGNATED "BOX" OUTSIDE OF WHICH USG MATERIAL AID (OR RELATED TRAINING) FOR COUNTER-NARCOTICS OPERATIONS COULD NOT BE USED. FULL TEXT OF AMENDMENT FOLLOWS. END SUMMARY.

2. PURSUANT TO REF A INSTRUCTIONS, ON JANUARY 21, 2000, COLOMBIAN MINISTER OF DEFENSE, LUIS FERNANDO RAMIREZ ACUNA, AND U.S. AMBASSADOR KAMMAN SIGNED THE AMENDMENT TO THE AUGUST 1, 1997 END-USE MONITORING AGREEMENT (EUM) GOVERNING USG MATERIAL AID, AND TRAINING RELATED TO IT, TO COLOMBIA FOR COUNTER-NARCOTICS PURPOSES. MOD ADVISED THAT AMENDMENT, LIKE THE EUM ITSELF, DID NOT NEED TO BE TRANSMITTED THROUGH THE MFA.

3. THE FULL TEXT OF THE AMENDMENT FOLLOWS:

"PURSUANT TO THE MEMORANDUM OF UNDERSTANDING BETWEEN THE GOVERNMENT OF THE REPUBLIC OF COLOMBIA AND THE GOVERNMENT OF THE UNITED STATES OF AMERICA CONCERNING THE TRANSFER,

USE, SECURITY, AND MONITORING OF ARTICLES, SERVICES OR RELATED TRAINING THAT MAY BE FURNISHED TO THE GOVERNMENT OF THE REPUBLIC OF COLOMBIA BY THE GOVERNMENT OF THE UNITED STATES OF AMERICA, SIGNED AT WASHINGTON ON AUGUST 1, 1997, THE GOVERNMENT OF THE REPUBLIC OF COLOMBIA AND THE GOVERNMENT OF THE UNITED STATES HEREBY DESIGNATE THE FOLLOWING AREAS AS THE "DESIGNATED AREAS" FOR THE PURPOSES OF THE MEMORANDUM OF UNDERSTANDING: THE ENTIRE NATIONAL TERRITORY OF THE REPUBLIC OF COLOMBIA, INCLUDING ITS TERRITORIAL WATERS RECOGNIZED BY THE INTERNATIONAL LAW, AND ITS AIRSPACE.

SUCH AREAS MAY BE MODIFIED OR AMENDED, OR EXCEPTIONS FOR URGENT SITUATIONS MAY BE ESTABLISHED, AT A LATER TIME BY MEANS OF ADDITIONAL IMPLEMENTING DOCUMENTS, IN ACCORDANCE WITH THE TERMS OF THE MEMORANDUM OF UNDERSTANDING.

IN LIGHT OF THIS REVISION OF THE "DESIGNATED AREAS" THE SEMI-ANNUAL HUMAN RIGHTS CERTIFICATION PROVIDED FOR IN PARAGRAPH 4 [OF THE MOU] SHALL COVER THOSE COLOMBIAN UNITS, IN ANY PART OF COLOMBIAN TERRITORY, WHICH HAVE ALREADY RECEIVED, ARE CURRENTLY RECEIVING, OR HAVE BEEN PROPOSED TO RECEIVE U.S. ASSISTANCE UNDER THE MEMORANDUM OF UNDERSTANDING.
