THE UNITED STATES NOTES WITH PLEASURE THAT IRAN HAS ENTERED INTO A SAFEGUARDS AGREEMENT WITH THE INTERNATIONAL ATOMIC ENERGY AGENCY WHICH IT INTENDS TO CONTINUE IMPLES MENTING. THE UNITED STATES AGREES THAT SUCH APPLICATION OF IAEA SAFEGUARDS CURRENTLY SATISFIES THE NEED FOR THE EXERCISE OF RIGHTS ENVISAGED FOR THE UNITED STATES IN PARAGRAPHS 1, 2 AND 3 OF ARTICLE 9 OF THE AGREEMENT. THE PARTIES SHALL REVIEW THE ADEQUACY OF THE APPLICATION OF IAEA SAFEGUARDS WHENEVER EITHER PARTY IS OF THE VIEW THAT MODIFICATION MAY BE REQUIRED.

THE GOVERNMENT OF THE UNITED STATES CONFIRMS THAT NOTHING IN THE AGREEMENT WOULD PRECLUDE IRAN FROM RECEIVING ANY POTENTIAL BENEFITS UNDER ARTICLE V OF THE TREATY ON THE NON-PROLIFERATION OF NUCLEAR WEAPONS, OTHER APPLICABLE INTERNATIONAL AGREEMENTS, AND THE DOMESTIC LAWS AND REGULATORY REQUIREMENTS OF THE RESPECTIVE PARTIES.

UPON RECEIPT OF HIS EXCELLENCY'S NOTE CONFIRMING THAT THE IMPERIAL GOVERNMENT OF IRAN SHARES THE ABOVE UNDERSTAND. INGS, THE EXCHANGE OF NOTES SHALL CONSTITUTE THE FORMAL RECORD OF THESE MUTUAL UNDERSTANDINGS AND SHALL BE AN INTEGRAL PART OF THE AGREEMENT. VANCE
