Pakistan/India Activities During Your Absence

The following is an update of Pak/India activities during your absence.

Paper on Nuclear Export Control Bilaterals

I have written a suggested itinerary and discussion topics for these bilaterals (separate paper). With the possible exception of a stop in Switzerland on this itinerary, I tried to err on the side of conservation and suggest stops only where I believe there is much to discuss and much to be gained by engaging in discussion on export control issues.

Demarche to Sweden on Flash X-Ray Assistance

Dean and I finally cleared a cable to Stockholm regarding upcoming technical assistance in flash x-ray systems for Pakistan. The preliminary response seemed positive (I have attached a copy of the response).

Demarche to Japan on Spectrometers

We have not yet received a response to the recent demarche to Tokyo on spectrometers for Pakistan.

Neutron Generator Purchase

I again asked Stephen Band if steps are being taken to prevent this purchase. He said he had not yet heard back from London, but would inquire again.

Demarche to Pakistan

NEA DAS Schaeffer was out of town, and as a result, NEA's support for a demarche is no longer assured. However, as of March 13, PM was still negotiating with NEA to try to get them back on board (if they decide against it, then it

There were more ridiculous developments on this subject. Two more reporting cables, as well as a letter for Shultz from Halefoglu, came in during your absence. One cable (LOU) included the text of new/old Turkish regulations banning the export of inverters over 450 Hertz. Another NODIS cable reported this control and also noted a news "leak" that the regulation was issued because such inverters were intended for use in Pakistan's nuclear weapons program (I believe this was a deliberate leak by the GOT).

The letter from Halefoglu states "...my Government has that further tightening of the measures still in force will with the enable us to resolve the issue in a satisfactor. This confirms my suspicions that this was all they planned to do. In the meantime, OES is still trying to clear a cable asking for "clarification"," and indicating that the response does not solve the problem. ACDA has had major problems with the cable because I believe the answer we have gotten is very clear, and there is nothing to be gained by further not believe anything short of a very high-level demarche here in Washington will be taken seriously by the Turks: We attempted to insert language into the cable indicating the issue would be raised in Washington in the near future. After OES could not get ACDA staff clearance, Kennedy called the Acting ACDA Assistant Director, who cleared the cable. Thus far, it has not gone out. India

We received the text of a written Q and A in the Indian Parliament regarding Tarapur spare parts. The answer, from MEA Narasimha Rao, indicated the statement that "the GOI recently handed over to the USG a list of spare parts required for Tarapur. It is the Government's expectation that the U.S. would live up to the obligation which it had earlier accepted." Although State seems to be relying on Raja Ramanna's

February 8 remarks to the U.S. Consul General in Bombay to the effect that negotiations with the Germans for spare were going well and those they could not get from the Germans could be indigenously fabricated, I thought the Rao response was worth noting anyway.
