1. SUMMARY: THE MONTREAL PROTOCOL ON SUBSTANCES THAT DEPLETE THE OZONE LAYER WAS ADOPTED ON SEPTEMBER 16, 1987. IN THIS HISTORIC AGREEMENT, THE INTERNATIONAL COMMUNITY ADDRESSES A SERIOUS THREAT TO A VITAL GLOBAL RESOURCE. ACTION REQUESTED: ALL ADDRESSEES ARE

2. BACKGROUND: THE PROTOCOL WAS NEGOTIATED UNDER THE AUSPICES OF THE UNITED NATIONS ENVIRONMENT PROGRAM. ALL STATES WERE INVITED TO PARTICIPATE IN THE CONFERENCE WHICH ADOPTED THE PROTOCOL, AND ALL STATES ARE ELIGIBLE TO BECOME PARTIES TO THE PROTOCOL. THE BROADEST POSSIBLE

PARTICIPATION IN THE PROTOCOL IS IMPORTANT TO ITS
EFFECTIVENESS -- BECAUSE OF THE LONG ATMOSPHERIC LIFETIME
OF THE CHEMICALS, EMISSIONS ANYWHERE AFFECT THE OZONE
LAYER OVER THE ENTIRE GLOBE AND OVER MANY DECADES. THUS,
IT IS IMPORTANT THAT BOTH MAJOR CURRENT PRODUCERS/USERS
AND COUNTRIES WHICH DO NOT NOW PRODUCE OR USE SIGNIFICANT
QUANTITIES PARTICIPATE IN ESTABLISHING A GLOBAL REGIME TO
DEAL WITH THE PROBLEM. VIRTUALLY UNIVERSAL PARTICIPATION
WOULD OBVIATE THE PROSPECT OF EXPANDED PRODUCTION BY
NON-PARTY "POLLUTION HAVENS."

3. THE PROTOCOL REQUIRES A FREEZE AND SUBSEQUENT SIGNIFICANT REDUCTIONS (OF TWENTY PERCENT BY 1994, AND OF FIFTY PERCENT BY 1999) IN USE OF CFC'S 11, 12, 113, 114, UNCLASSIFIED

AND 115 AND A FREEZE ON HALONS 1211, 1301, AND 2402. THESE MEASURES WILL BE PERIODICALLY REASSESSED BY THE PARTIES ON THE BASIS OF DEVELOPING SCIENTIFIC, ENVIRONMENTAL, ECONOMIC AND TECHNICAL INFORMATION. THE PROTOCOL WILL ALSO BAN IMPORTS FROM NON-PARTIES OF THE CONTROLLED SUBSTANCES AND PRODUCTS CONTAINING THE SUBSTANCES, POSSIBLY BAN OR RESTRICT IMPORTS FROM NON-PARTIES OF PRODUCTS MADE WITH (EVEN IF NOT CONTAINING) THE SUBSTANCES, AND PROHIBIT FINANCIAL ASSISTANCE TO NON-PARTIES FOR PRODUCING THE SUBSTANCES. (THE PROTOCOL IS GATT-CONSISTENT. A USTR PAPER WILL BE SENT TO ALL ADDRESSEES FOR YOUR USE SHOULD GOVERNMENT RAISE GATT CONCERNS.)

4. A TEN YEAR GRACE PERIOD IS ALLOWED FOR LOW-CONSUMING (UNDER .3 KG PER CAPITA CONSUMPTION) DEVELOPING COUNTRIES, TO ENCOURAGE BROAD PARTICIPATION AND TO ALLOW FLEXIBILITY FOR THE DEVELOPING COUNTRIES DURING THE TRANSITION PERIOD UNTIL ADDITIONAL SUBSTITUTE CHEMICALS ARE DEVELOPED AND COMMERCIALLY AVAILABLE. IN ADDITION,

- 5. THE CONTROLLED CHEMICALS ARE WIDELY USED IN AEROSOLS (BANNED IN THE U.S. SINCE 1978), REFRIGERATION AND AIR CONDITIONING, FOAM-BLOWING, AND AS SOLVENTS IN THE ELECTRONICS INDUSTRY. THE PROTOCOL IS DESIGNED TO PROVIDE A STRONG INCENTIVE FOR DEVELOPMENT AND USE OF ALTERNATIVE CHEMICALS (INCLUDING LESS-DEPLETING OR NON-DEPLETING CFCS) AND PROCESSES (E.G., RECYCLING); AT THE SAME TIME, IT ALLOWS ADEQUATE TIME FOR ADJUSTMENT, PARTICULARLY FOR DEVELOPING COUNTRIES.
- 6. THE PROTOCOL SETS A TARGET DATE OF JANUARY 1, 1989 FOR ENTRY INTO FORCE, WITH THE FREEZE TO BEGIN JULY 1,

- 1989. THIS REFLECTS CONSENSUS (WHICH US STRONGLY SUPPORTS) THAT IT IS NECESSARY TO BEGIN MEASURES TO LIMIT EMISSIONS AS SOON AS POSSIBLE, BUT IS A TIGHT SCHEDULE. TO ACHIEVE THIS, STATES WILL HAVE TO BEGIN THEIR RATIFICATION AND IMPLEMENTATION PROCEDURES NOW. THE UNITED STATES, WHERE SUPPORT FOR THE PROTOCOL IS STRONG, THESE PROCEDURES WILL TAKE SEVERAL MONTHS. WE EXPECT THIS WILL BE THE CASE IN MOST OTHER COUNTRIES, AND THEREFORE REQUEST EMBASSIES TO URGE HOST GOVERNMENTS TO BEGIN THE PROCESS NOW. (FYI -- AN ENVIRONMENTAL IMPACT STATEMENT MUST BE SUBMITTED TO THE SENATE WITHIN THIRTY DAYS OF TRANSMITTAL OF THE PROTOCOL FROM THE PRESIDENT TO THE SENATE FOR ITS ADVICE AND CONSENT TO RATIFICATION; IT IS NOW BEING PREPARED AND IS TO BE COMPLETED IN EARLY JANUARY. THE U.S. DOMESTIC RULEMAKING PROCESS IS WELL UNDERWAY - A PROPOSED RULE WILL BE ISSUED IN DECEMBER 1987 AND A FINAL RULE IN AUGUST 1988 - WHICH WILL PUT IN PLACE THE MECHANISMS NECESSARY FOR U.S. IMPLEMENTATION OF THE PROTOCOL BY JANUARY 1, 1989, THE DATE SPECIFIED IN THE PROTOCOL FOR ENTRY INTO FORCE.)

TO ENSURE THAT THE ECONOMIC BURDEN OF THE CONTROLS IS EQUITABLY SHARED AMONG CURRENT MAJOR USERS OF THE CHEMICALS, THE PROTOCOL WILL ONLY ENTER INTO FORCE WHEN ELEVEN COUNTRIES REPRESENTING TWO-THIRDS OF GLOBAL CONSUMPTION HAVE RATIFIED THE AGREEMENT. WE HOPE THAT MANY OTHER COUNTRIES WILL ALSO RATIFY DURING 1988, REFLECTING THE RESPONSIBILITY OF ALL NATIONS TO TAKE THESE JOINT MEASURES COOPERATIVELY. BROAD ADHERENCE DURING 1988 WILL ALSO ENSURE THAT THE FIRST MEETING OF

TWENTY-FOUR COUNTRIES PLUS THE EEC SIGNED THE PROTOCOL AT MONTREAL: BELGIUM, CANADA, DENMARK, EGYPT, FINLAND, FRANCE, FRG, GHANA, ITALY, JAPAN, KENYA, MEXICO, NETHERLANDS, NEW ZEALAND, NORWAY, PANAMA, PORTUGAL, SENEGAL, SWEDEN, SWITZERLAND, TOGO, UK, US, VENEZUELA, EEC. OTHER DELEGATES (E.G., USSR, AUSTRALIA) INDICATED THEY EXPECT THEIR GOVERNMENTS TO SIGN AND RATIFY. FOLLOWING COUNTRIES PARTICIPATED IN MONTREAL BUT DID NOT IMMEDIATELY SIGN THE PROTOCOL: ALGERIA, ARGENTINA, AUSTRALIA, AUSTRIA, BRAZIL, BURKINA FASO, BYELORUSSIAN SSR, CHILE, CHINA, COLOMBIA, CONGO, COSTA RICA, CZECHOSLOVAKIA, DEMOCRATIC YEMEN, GREECE, INDONESIA, ISRAEL, REPUBLIC OF KOREA, LUXEMBOURG, MALAYSIA, MAURITIUS, MOROCCO, NIGERIA, PERU, PHILIPPINES, SPAIN,

YOU SHOULD ALSO BE AWARE THAT TWO WEEKS AFTER ADOPTION OF THE PROTOCOL, ON SEPTEMBER 30, 1987, PRELIMINARY FINDINGS OF THE CAMPAIGN TO STUDY THE SPRINGTIME DEPLETION OF OZONE OVER THE ANTARCTIC WERE RELEASED. THE ABUNDANCE OF OZONE IN AUGUST AND SEPTEMBER 1987 WAS LOWER THAN ANY PREVIOUS YEAR AT ALL LATITUDES SOUTH OF 60 DEGREES; IN MID-SEPTEMBER, COLUMN OZONE WAS APPROXIMATELY FIFTEEN PERCENT LOWER THAN THE LOWEST PREVIOUS YEAR (1985). THE EVIDENCE STRONGLY SUGGESTS THAT BOTH CHEMICAL AND METEOROLOGICAL MECHANISMS PERTURBED THE OZONE. A MORE COMPLETE AND FINAL INTERPRETATION OF THE ANTARCTIC FINDINGS WILL BE FORTHCOMING IN ABOUT SIX MONTHS. ALSO, A NASA/NOAA REVIEW OF GLOBAL MEASUREMENTS WILL BE COMPLETED LATE THIS YEAR. PLEASE ALSO OBTAIN FROM UNEP THE LIST OF COUNTRIES WHICH WOULD BE CONSIDERED TO BE "DEVELOPING" AND THEREFORE ELIGIBLE FOR TREATMENT UNDER ARTICLE 5. (IWONA RUMMEL-BULSKA SAID THIS WOULD BE BASED ON A STANDARD UN LIST.) SHULTZ
